Re: 2020 IWF Pan-American Championships [UPDATED]

On behalf of the CWFHC, we are pleased to provide you with an updated memorandum for the 2020 Pan-American Championships (the "Competition") taking place in Santo Domingo, Dominican Republic from April 17 - 24, 2020. This memo provides you with some important information to help you and your athletes prepare for the Competition.

1. QUALIFICATION STANDARDS

Following an athlete appeal concerning the increase in qualification standards from 2018 to 2019 and the delayed release of the Preliminary Memo on the Competition in November 2019, the CWFHC has revised the qualification standards for 2020. These changes are in effect for the 2020 Pan American Championships only. Athletes and coaches should expect higher standards for the 2021 Pan American Championships.

2. FUNDING STANDARDS

The minimum threshold for an athlete to receive funding for the Competition remains 90% of the Marker, as detailed below, consistent with historical practice.

3. QUALIFICATION EVENTS

The very early date of this year's competition means that the regional championship events that traditionally served as Pan American qualifiers cannot serve as qualifiers this year. Instead, the following IWF and regional competitions scheduled within the sixmonth period before the Competition serve as the qualification events:

Athlete rankings will be determined at the end of the qualification period.

4. CONFIRMATION OF PARTICIPATION

All qualified athletes, coaches, and support personnel who would like to participate in the Competition must submit their Declaration of Intent to Participate in the Competition and deliver the \$100 CWFHC Administration Fee by **Friday**, **January 31**, **2019** at the latest. Declarations may be sent to Mr. Aaleem Patel, CWFHC Secretary-Treasurer by email at apatel@cwfhc.ca.

The CWFHC is working with our bank to set up an e-transfer system for payment of the administration fee. We will provide an update on the payment arrangements as soon as the Competition Regulation is released.

5. FUNDING FOR COACHES AND ATHLETES

- (a) Athletes: The top 2 female and top 2 male athletes who meet the Minimum Threshold for Funding will receive 80% support for registration fees, anti-doping fees, and accommodations for 4 nights based on double-occupancy, and flight to Santo Domingo, Dominican Republic (Air Canada Basic Economy fare or equivalent).
- **(b)** Coaches: The coach of the top female athlete and of the top male athlete will receive 100% support for registration fees, accommodations, and flight to Santo Domingo (Air Canada Basic Economy fare or equivalent). The CWFHC will determine the date by

which funded coaches must arrive in Santo Domingo after the IWF releases the Competition Regulation.

The CWFHC will determine the maximum number of coaches to send following the release of the Competition Regulation.

(c) Team Leader: If the CWFHC determines that a Team Leader is required for this event, the Team Leader will receive 100% support for registration fees, accommodations, and flight to Santo Domingo (Air Canada Basic Economy fare or equivalent). The Team Leader is expected to arrive with or before the first group of athletes and coaches and fulfil all other duties assigned by the CWFHC.

The CWFHC will circulate a request for declarations of interest to serve as a Team Leader during the 2020 season. If a Team Leader is required for the Competition, the Team Leader will be selected from that roster.

6. ANTI-DOPING

The IWF has set February 17, 2020 as the deadline for filing Whereabouts. If you are not already registered in ADAMS, or if you need to reset the password to your ADAMS account, please contact Victor Twynstra at the Canadian Centre for Ethics in Sport by phone at 1(613) 521-3340 for assistance.

7. REGISTRATION FEES, ACCOMMODATIONS, TRAVEL

The CWFHC will circulate further details on registration fees, accommodation, travel, and deadlines following the IWF's release of the Competition Regulation. Flights to Santo Domingo are expected to cost between \$700-\$1000 in April 2020.
